

Boarding and Daycare Contract

is in good health and has not harmed or shown aggressive behavior towards any person or other dog or if so, the incident has been disclosed prior to boarding/daycare drop-off. As the signing party, I have presented all legal documentations proving that I am the legal owner or agent of said pet. All information given is accurate. My dog(s) have been vaccinated according to Two Peas and A Paw’s requirements, has not been exposed to Rabies, Canine Distemper, Kennel Cough viruses within the past 30 days and all vaccines are up to date.

I agree to take precautions against contagious illness and parasite exposure by consulting with my Veterinarian prior to my dog attending Two Peas and A Paw for I have been thoroughly informed all clients must have proof current Rabies, Bordetella, and other annual shots. I have disclosed all information regarding food or medication allergies to prevent undue complications.

I fully accept all reasonable risks of illness or injury that may be obtain during normal daycare/boarding activities. Such risks include, but are not limited to: cuts, scrapes, and other minor injuries resulting from rough play and possible contagious illnesses such as upper respiratory infections. I release Two Peas and A Paw, LLC of any liability that may occur from my dog(s) attendance and participation in activities while on the premises.

I understand that Two Peas and A Paw agrees to exercise reasonable care in the handling of my dog(s) and keeping the facility properly secured and cared for daily. All dogs are cared for by Two Peas and A Paw staff without liability on Two Peas and A Paw’s part for loss or damage from disease, theft, fire, death, escape, injury, or harm to persons, other dogs, property, or for other unavoidable causes, due care and diligence having been exercised.

I understand and agree that should my dog become ill or in need of medical attention, Two Peas and A Paw will first try to contact me and then my emergency contact reference provided on my Customer Information Form. If unable to reach me in an emergency, Two Peas and A Paw management reserves the right and sole discretion to administer aid and/or to use any available veterinarians without liability, and I agree to promptly pay for all medical treatments received.

In the event of an emergency, every effort will be made to contact the Emergency Contact listed in my file. Should the emergency be time sensitive, the Staff at Two Peas and A Paw will seek authorization on behalf of my pet, and my emergency contact will be called to make further decisions.

I understand Two Peas and A Paw are not responsible for any lost or damaged items left during the time my dog(s) are left for Daycare and/or Boarding. I understand that my dog will only be released to the owner(s) on file, unless prior arrangements have been made, in writing, with a staff member. I understand that Two Peas and A Paw closes at 7:00 pm. At that time, a staff member of Two Peas and A Paw will attempt to contact me and then my listed emergency contact to come pick up my dog(s). If no one can be reached, my dog will be boarded and all incurred charges will be paid upon pick up.
